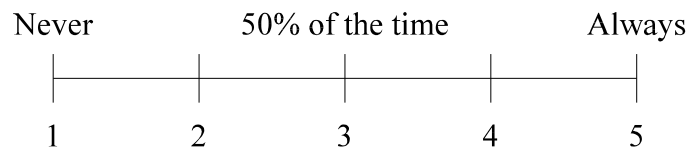

Student Evaluation of Field Practice

Just as there are regular evaluations of each course taken at the College of Social Work, all students are requested to evaluate their field practicum experience. These evaluations provide a profile of the practicum instruction received by students and a source of feedback to the field coordinator concerning student perceptions of their experience in the practicum. Students are asked to complete the evaluation and return it to **the field secretary**. **The forms will not be given to the field coordinator until after grades are submitted.** A copy of the evaluation will be shared with instructors once grades have been submitted, **if the student gives permission**. 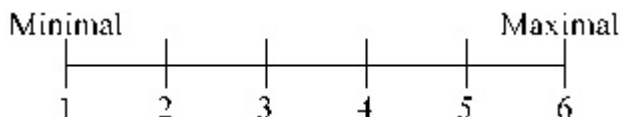
Rate the extent to which your field instructor:
